And speaking of events, we have our own events coming up this summer that I'm sure you will all enjoy.

To begin the NWFT Summer events, be sure to make time to join us on Saturday July 24th for our first summer event of the season. We will be having a YRE group walk in Ashland, NE, on Saturday, July 24th. We will be meeting at 10 a.m. at Wiggenhorn Memorial Park, which is located at 2600 Clay St, in Ashland. This event will be a modified 5k walk. If anyone is interested in walking the 10k, you can register at the normal start box. If you choose the 10k option, just please be sure you are back at the park at around 11am for lunch

The walking waiver will be signed on the day of the event, with book stamping available. The cost of this walk is \$3, unless you have already walked this event earlier this year, then walkers would pay \$2.

We also have an option to purchase a box lunch from Cheri O's of Ashland for this event. The lunch will include a ham, turkey, or roast beef sandwich, a bag of chips, a chocolate chip cookie, and a bottle of water. The cost for this box lunch is \$9 for members and \$10 for non-members.

We are pre-reserving the box lunches for this walk. If you are interested in attending and want to purchase one of these box lunches, please mail in your check, made out to NWFT for \$9 for members (\$10 for non-members) to the below address. The deadline for us to receive your payment in order to purchase/ pre-reserve one of these box lunches is July 15th.

Directions for this Ashland event: From I-80 westbound take exit 432 (for NE-31). Right to NE-31 to US-6/ Gretna/Ashland 0.2 miles. Left on US-6 about 7.4 miles. Turn right onto Silver St. 0.6 miles, then turn right onto N 14th street 0.2 miles. Turn left onto Clay St. for 0.8 miles, and then you are at your destination for Wiggenhorn Memorial Park, 2600 Clay St.

Also, scheduled later this season is our 2nd summer event located at Chalco Hills Recreation Area. This YRE group walk event will take place on Saturday August 14th at 10 a.m. We will be meeting for this walk event at picnic shelter D. Enter Chalco from the north near 156th and Giles. Proceed following signs to the boat ramp. The road will curve and at the stop sign turn left following signs to the picnic areas. Continue straight south to picnic area D.





She graduated from Grand Island Senior High May 29, 1957. She graduated from Nebraska State Teacher's College at Kearney on Aug. 4, 1961, with a Bachelor of Arts Degree in Education. She taught Art Education in Fairbanks, Alaska. Glenda taught for a few years in Ord before returning to Grand Island. In 1969, Glenda began teaching at Grand Island Northwest High, where she taught Physical Education and coached many girls' volleyball teams until her retirement in 1998. Glenda was fiercely independent and spent her summers exploring all 50 states. Glenda was employed at Yellowstone National Park for many summers and she shared her passion for the outdoors with many young campers. She enjoyed seeing all of the sights as a member of the American Volkswalk Association. Glenda has completed organized walks in all 50 states. She was a member of the Mid-Nebraska Trail Seekers Volkswalk Club, and as the Trailmaster, she mapped out volkswalks in Grand Island. Glenda planned many trips with her sister, Joyce, nieces and nephews that included a few walks as well. Glenda was never idle and was a member of the National Women's Bowling Association for over 35 years and competed at State many times. She also enjoyed card games and had several groups she played with. She had a variety of collections, and would always set a beautiful table for each holiday.
